President Carolyn Sturgeon called the meeting to order.

1. Approval of minutes of previous meeting on April 7, 2006.

Denise Duerksen, Newton, moved and Pat King, Winfield, seconded that the minutes be approved. The minutes were approved unanimously.

2. Treasurer's Report

The financial report and 2007 Proposed Budget were distributed for review. Susan Wettstein, Garnett, moved and Sandie Masden, Dodge City, seconded to approve the financial report and the 2007 Budget as submitted. The motion carried unanimously.

3. Committee Reports

Professional Development: Sandie Masden, Dodge City, reported on the CMA (Certified Municipal Assistant) certification. Sandie reported on the following:

- Applications for CMA certifications are accepted in the fall. The Professional Development Committee will review the applications that have been submitted and award the CMA plaques and pins at the Spring Conference.
- Sandie reviewed the point structure on the CMA application.
- A survey was sent out for topics of discussion at future conferences.
- The committee is working on a pin for the CMA award.

Membership: Linda Razo, Hutchinson, reported the City of Horton has expressed interest in joining AAKC. She passed out an updated membership sheet. Linda requested that the Publications Committee design a new post card for mailing to prospects.

Publications: Barb Slagle, Dodge City, reported that the Publications Committee has completed the following items since the Spring 2006 meeting:

- Updated the AAKC Web site – Membership page, conferences page, committees page, and links page
- Assisted Darlene (City of Abilene) with the Fall Conference brochure—designed and printed it for mailing
- Made an advertisement flyer for the Kansas Government Journal

Barb also reported that the Publications Committee is working on other projects as follows:

- Online form for attendance tracking at conferences
- Adding membership page to the web site
- Adding By-Laws to the web site
- Adding Agendas and Minutes to the web site, perhaps in a “Document Center” structure

The meeting was temporarily adjourned for lunch at 12:10 p.m.

Meeting reconvened at 1:00 p.m., resuming under Committee Reports.

Sarah Somerhalder has updated the birthday list and they were passed out. Discussion was held on recognition for 5-10 year members. Pat showed some samples of plaques. Discussion was held on giving a plaque to departing members. Wilma Lister, Winfield, volunteered to be on the Public Relations committee. The committee will clarify their committee description and submit it at the Spring 2007 meeting.

4. Old Business

A. Carolyn Sturgeon discussed the booth at the LKM Conference in Topeka, Oct. 8-10, 2006:

- Susan Evenson, El Dorado, will chair the Booth Committee. Others who volunteered to help with the booth were Jennifer Gutierrez and Sandie Masden, Dodge City; Linda Jones, Osage

City; and Megan Williams, Great Bend. Megan will help with design of publications, etc., but may not attend the LKM conference.

- Carolyn reminded everyone that the AAKC Breakfast is on Tuesday, October 10, at 7:30 a.m.
- Discussion on a give-away from our booth was held. It was decided to give away a smoke-colored pen-like tool that contains a small screwdriver, etc., with our AAKC logo on it.
- Nancy Crain, Arkansas City, volunteered to share the Power Point presentation that she had prepared for last year's booth so it could be updated for this year.

WHAT'S HAPPENING IN YOUR CITY?



From Hutchinson~

The Kansas Underground Salt Museum is now scheduled to open in late 2006 or early 2007! Let's take a tour!

From Olathe ~

There is a lot happening in the city that Money Magazine recently named as the *thirteenth best place in the country to live*. Here are a few highlights:

127th Street Overpass

- Project is ahead of schedule
- Scheduled to be open to traffic in December (original completion time was September of 2007)
- Improvements to surrounding roads as well
- Improvements to Kansas City Road are near completion
- Improvement to 127th and Mur-Len are starting

Railroad Track Elevation

- Project is in response to top priority of citizens to reduce traffic congestion
- Project will eliminate railroad crossings at Ridgeview, Santa Fe, Park and Loula
- Forty trains per day cross these four streets
- Santa Fe crossing is 2nd busiest in the state
- Trains will run on new tracks by August of 2007
- Further improvements will continue through April of 2008

K-State-BioScience

- Project includes Kansas State University, a bioscience research park and a bioscience business incubator
- Located on northwest corner of College Boulevard and Kansas Highway 7
- In partnership with Johnson County Government, the Kansas Bioscience Authority and Kansas State University

Destination Retail Plan at 119th and I-35 (Bass Pro Shop)

- Bass Pro Shop two story retail store is on schedule to open on February 22, 2007.
- The store will open complete with the Islamorada Fish Company Restaurant and Starbucks
- 19,000 gallon fresh water aquarium construction within the store is scheduled to be stocked with native fish species on January 1, 2007
- The Olathe Bass Pro Shop is the first in Kansas, and is expected to create 250 jobs
- Renner Road will be complete with final surfacing and ready to open from KC Road to 119th in November as scheduled
- Construction of the lifestyle center (retail shops with open plaza area) to begin in about 2 weeks

From Emporia ~

The turnpike project has started on the west side of Emporia. The Kansas Turnpike Authority decided the time had come to straighten out the maze ("spaghetti bowl") with some help from the city government and the Kansas Department of Transportation. "With luck, and a pair of roundabouts, spaghetti would soon be off the menu." The project includes a new plaza and the roads leading up to it, particularly on a new set of entrance and exit ramps for northbound and southbound traffic. Also, two new bridges will be constructed over one of the roundabouts. During construction, there will be four detours to reroute traffic until the project is completed (project to be completed in approximately two years).

Planning Emporia's 150th year anniversary on February 20, 2007. On February 20, 2007 there will be a 150th Anniversary birthday party at the Civic Auditorium arena. The 150th Anniversary time capsule (safe) was opened 4-1-06) and the contents removed. The contents of a scrap book, movie, top hat, centennial coin and mold and other items are on display at the Lyon County Historical Museum. 150th Year Anniversary activities will continue throughout the year.

Emporia will be getting information kiosks to be put throughout the downtown area. These kiosks will be attached to light poles (if approved) similar to the ones in Garden City.
